

## Lake Constance travel pass, conditions of participation

By participating in the competition (Lake Constance travel pass) organised by Internationale Bodensee Tourismus GmbH, every user accepts the following conditions. The user is obliged to consider and accept all details. The judges' decision is final; all information is given without warranty.

### 1. Organisation

The competition is organised by Internationale Bodensee Tourismus GmbH, Hafenstr. 6, 78462 Konstanz, Germany (named IBT GmbH in the following).

### 2. Participants

This competition is open to all persons aged 18 or over. Employees of Internationale Bodensee Tourismus GmbH or employees of companies affiliated with Internationale Bodensee Tourismus GmbH as well as immediate family members of the aforementioned employees (including spouses or partners, parents, siblings, children or other people living in the household) are excluded from participating. The respective organiser reserves the right to check the identity and eligibility of the participants. Every person can only participate in this competition once.

### 3. Participation

This competition is valid between 01.01.2018 and 31.12.2018. The winner will be announced in January 2019.

Participation is dependent on the fully stamped Lake Constance travel pass (one stamp from each country) being submitted to Internationale Bodensee Tourismus GmbH in person, by post or by e-mail. All company stamps of tourist information offices, hotels and destinations in the Lake Constance region are valid. The travel pass must be submitted within the deadline indicated. The participant is responsible for the accuracy of the information and e-mail address provided. All personal details must be truthful and accurate otherwise the participant may be excluded. Participation is free of charge.

### 4. Prizes

The prizes are provided by partners of Internationale Bodensee Tourismus GmbH. Internationale Bodensee Tourismus GmbH declines all liability for the faults on merchandise. Additional services (e.g. outward/return journeys) are not included in the prize. All operating, ancillary and subsequent costs related to the prize will be

borne by the winner. The prizes are personal and cannot be transferred. The judges' decision is final and no cash payment of the prize is possible.

#### **5. Notification of the winners**

The winners will be determined by lottery. The winner will be notified by Internationale Bodensee Tourismus GmbH by e-mail. If no direct contact is possible within one week of the notification being sent to the winner, entitlement to the prize will be forfeited. In this case, a new winner will be drawn and the original winner loses all entitlement to the prize. By sending the prize, the risk of accidental loss passes to the winner. The names of the winners can be published in the web and print presences of Internationale Bodensee Tourismus GmbH. The participant explicitly agrees to this form of publication.

#### **6. Exclusion of participants**

IBT GmbH reserves the right to exclude participants who make false or incomplete information, who use unauthorized aids that are suspected of tampering or otherwise violate the terms of participation, without stating reasons. If a participant is excluded, profits can also be subsequently revoked and reclaimed. The IBT GmbH reserves the right to ask the participant to comment on suspicion of an exclusion reason. If the statement is omitted within the deadline set by IBT GmbH, it reserves the right to exclude the participants from participation. Further reasons for exclusion are set out in Section 2.

IBT GmbH assumes no responsibility for data loss, in particular those caused by data transmission, technical defects and lost, damaged or delayed entries due to network, hardware or software problems. Any warranty claims of the winners are excluded.

## 9. Changements

Internationale Bodensee Tourismus GmbH can interrupt or end the operation at any time without prior notice and without giving any reasons for this decision if significant reasons prevent the proper implementation of the operation.

IBT GmbH is in particular entitled to discontinue, cancel or suspend the competition if

- An attempted manipulation is found
- proper operation is no longer ensured, especially in the event of hardware or software failure, program errors, computer viruses or unauthorized interference by third parties, as well as mechanical, technical or legal problems.

## 10. Final Provisions

The sole law applicable is the law of the German Federal Republic. If individual conditions of these conditions of participation are or become invalid, the validity of the remaining conditions of participation remains unchanged. Internationale Bodensee Tourismus GmbH is entitled to exclude submissions from participating which violate these conditions of participation, without giving any reason. The legal process is excluded.

We inform you that IBT GmbH does not participate in dispute resolution proceedings of a consumer arbitration board and is not obliged to do so.
